

TOKO TRAILERS LTD

WARRANTY

Toko Trailers warrants to the original purchaser, under normal conditions and use, each new Toko Trailer to be free from faulty workmanship and materials for the periods listed below.

During this warranty period Toko Trailers shall repair or replace any item covered by the warranties listed, within reasonable time after the trailer is returned to Toko Trailers Factory or authorized Toko Trailers repairer.

Two Year Warranty

Toko Trailers warrants each boat trailer frame and its fabricated steel components, including the ball coupling and wheels (but excluding tyres and tubes) to be free of structural or welding defects for a period of two years from the date of original purchase.

One Year Warranty

Toko Trailers warrants the hot dipped galvanised finished surface of each boat trailer and its components for a period of one year from the date of original purchase against red rust. This extends to U Bolts, nuts, bolts, mechanical braking equipment and manual winches but excludes straps and cables.

Toko Trailers warrants hydraulic braking equipment, axles, wheel bearings, seals, and tyres for a period of one year from the date of purchase.

Six Months Warranty

Toko Trailers provides a warranty on all Trailer Lighting and Electrical Components for a period of six months from the original date of purchase.

This excludes any components damaged due to an accident, misuse or negligent use.

Commercial Use

For Toko Trailers that are found to be used for commercial practices, a maximum of a one year warranty applies.

Nothing in this warranty limits or restricts a statutory right or remedy available to you under the Consumers Guarantees Act 1993.

Conditions of the Warranty:

1. The Toko Trailers Warranty only extends to the original purchaser; they do not cover any persons whom the trailer has been transferred. Warranty claims are subject to delivery of the trailer to Toko Trailers or dealer with proof of ownership and date of purchase.
2. This warranty shall become void if the Toko Trailer is found to have been altered or repaired without prior authorization of Toko Trailers.
3. No Warranty claim will be accepted by Toko Trailers if it is found that the trailer has malfunctioned due to failure to provide reasonable and necessary maintenance, or expected wear through normal use.
4. A Warranty claim shall be declined for the Toko Trailer if it has been found that the problem exists due to overloading. (i.e. in excess of the gross vehicle mass stated on the trailer certification plate)
5. This Warranty does not cover the cosmetic appearance of the Toko Trailers galvanised surface or its components, as this changes with age after the trailer leaves the factory.
6. This Warranty does not extend to brake pads, rubber wheels, bow rollers, keel rollers, wobble rollers and winch and brake cables.
7. Costs involved in delivering the Toko Trailer to Toko Trailers Factory or authorized repairer for repairs under this warranty shall be the responsibility of the purchaser.
8. All work carried out under this warranty must be authorized in writing by Toko Trailers Ltd. Toko Trailers will not bear any responsibility for any work done without prior authorization.
9. Toko Trailers will not be liable for any special or consequential damages or cost of any kind or nature.
10. For the Warranty to be valid the Trailer's warranty card must be completed and returned to Toko Trailers **within 20 days of the purchase date.**
